Introduction

Businesses over the last decade have had to navigate a monumental shift in how software is licensed. Gone are the days of buying software and paying, at most, a yearly service fee. Subscriptions, Software as a service (SaaS) and short-term software licensing is the new normal. Managing a few licenses can be done with simple calendar alerts or spreadsheets, but there comes a point where businesses need more.

In this, though, there are a dizzying array of choices. Researching for a simple license management tool soon leads you into the world of software asset management (SAM), Enterprise asset management, and IT infrastructure library (ITIL). Tools at this level are megalithic- feature rich, multi-use one stop shopping for every use case you can imagine.

But what if you don't need all that?
What if you just want an easy way to manage your licenses?
What if you can't tie up your IT department for weeks while they manage set up?

This paper highlights the need for a Goldilocks solution—something in the middle that is just right, and introduces the CUBES License Manager from Tangent.

Definitions

IT Infrastructure Library: ITIL, defined best practices for IT activities such as IT service management and IT asset management that focus on aligning IT services with the needs of business.

License Term: Conditions of the license. Often include license duration, number of users, individual machine installs and other details.

Onramp Process: Series of procedures for managing highly complex software integrations. Often requires dedicated IT assets.

Software as a Service: a subscription-based licensing model for centrally hosted software.

Software Asset Management: A series of administrative processes, policies and procedures enacted to maintain compliance with the procurement, deployment, use, maintenance and depreciation of software applications.



Decisions, Decisions

All it takes is one day of having a domain expire to teach you how important license management is. What happens when critical projects are delayed because Photoshop has expired and the designers can't get into their work? That SaaS you signed up for but keep meaning to cancel before it auto renews? The question is not IF you need a system. The question is which one.

In-house

Simple spreadsheet are very good tools for rudimentary license management. Small business can save lots of money by setting up an in-house system. It's a familiar tool that many of us use every day, and have years of experience with. A spreadsheet can easily manage renewal dates, keep track of costs and itemize license term details. Paired with a system of calendar alerts, this can serve a company very well through the initial growth period.

The spreadsheet/calendar combo will have issues scaling. Imagine trying to manage 20 licenses that need to be updated in one program, then have alerts managed in another—it gets cumbersome quickly. Additionally, as neither of these tools is built for this purpose data entry and upkeep is not very efficient. As a company grows, owners want efficient answers with more features.

Professional Grade

There should be more solutions here, but there just aren't. Smaller and mid-size companies are faced with a dearth of options—tools seem either too big or too small. Growing enterprises should have the option of getting their needs met without overinvesting. Solutions in this market should offer features growing businesses need without all the complex overhead of the enterprise level tools.

CUBES license management is one such tool.

Enterprise Level

The need for robust feature sets in a pivotal point in enterprise level license management tools. Frequently, at this level, license management is a feature of a much larger and more complex piece of software. If you are monitoring software licenses, it follows that you will need to know how often that software is accessed, so you can tell if you need to keep that agreement active. And while you are doing all that, why not do some version control?

It all logically builds on its self until you have a megalithic tool, with scores of



features, massive IT integration, multi-level administration, coverage for every use case... and a price tag to match. (When you can get a price, at least) Rolling out this software often requires a dedicated IT team for weeks on end, and one or two assets to remain dedicated to maintaining the product. Solutions like this are not even in the cards for all but the largest companies.

Criteria for decision

A myriad of factors that play into the decision to stay with an in-house solution or upgrade. The 80/20 rule (Pareto Principal) plays into this-- the rule states that 80% of effects come from 20% of causes. With software, this means 80% of users will only use 20% of the features. Cost, onramp process and learning curve... it all has a role to play in deciding if and when to move on from in-house solutions.

When in-house is best

It's easy to get rudimentary license control using Excel, Google Sheets, or some other spreadsheet program. CUBES makes our Excel template freely available-it's a great starting point for keeping track of software licenses, SaaS subscriptions, and even warranties. When you have 4-12 items to track, and don't care that you are not keeping historical costs, this can work great. Using pivot tables and report builders will allow you to isolate data and make some rudimentary charts and graphs. Paired with a solid system of calendar-based reminders, you can keep it going while you concentrate on growing your business.

Eventually you'll need to look at efficiency tradeoffs. What only takes a few minutes for 10 licenses may become inconvenient at 20, and evolves into a slog as more license term details are tracked. The quantity and richness of data you are tracking will eventually outstrip the capabilities of what you can do with a spreadsheet and calendar reminders.
